Cycling

19 cyclists attended 11 of whom cycled several times per week, 4 once per week and the remainder less often.

All 19 said that they would like to see more traffic free cycle routes and 18 agreed that circular routes around the new housing developments would be useful.

16 cyclists said that more cycle stands were needed with several specifying outside the Co-op, school and by bus stops.

12 confirmed that an increase in cycle routes – particularly along the A420, would mean they used their car less.

Participants were asked to draw on a map the possible potential route of traffic free cycle ways.

12 participants identified a circular route from Days Ground running down Penny hooks Lane and along the perimeter of the Strategic development site through Becketts Ridge to Colton Road.8 of these participants suggested a cross link to manor Close and or Claypits Lane. 3 participants suggested a link from the Longcot Road to Stainswick lane and one between Stainswick Lane and Station Road.
