- i. **Deadline 25th January 2018 – P17/V3296/FUL** - Co Op Supermarket, High Street. Existing bank to be incorporated into the existing Co Op supermarket with relocation of access road. **Awaiting determination.**
- ii. **Deadline 30th January 2018 – P17/V2785/O** - Shrivenham Park Golf Course Pennyhooks Lane. Amendment no.1 – change to redline. **Permission granted.**
- iii. **Deadline 31st January 2018 – P17/3400/LB** - Beckett House Defence Academy. Minor works to enable better access for wheelchair users. **Permission granted.**
- iv. **Deadline 6th February 2018 – P17/V3351/HH** - 2 Catherine Close. Demolition of single storey flat roofed garage and erection of two storey side extension. **Permission granted.**
