| | using the area as a toilet, and that he was loudly vocal at night. He insisted that |
| | the Parish Council obtain a court order to evict him. |
| | A resident of Bowler's Green had spoken to a police officer today. She had |
| | witnessed drugs being sold to the main in the car park and believed that he was |
| | suffering from drug induced psychosis. She had seen him talking to invisible |
| | people and believed him to be dangerous. The police had told her that if the man |
| | is seen acting in this way, she should call 999. |

| | A resident of Highworth Road complained that the man could see the activity in |
| | their house from his position in the car park. They could hear him shouting at |
| | night from their home. A police officer had visited her today. She was frightened of the man and worried about the situation. She wanted to know what action the |
| | Council was taking. Cllr Bartle asked what action she had taken. She replied that |
| | she didn't think it was her responsibility. |
| | She didn't think it was not responsibility. |
| | Another resident of Bowler's Green stated that he had been monitoring the man |
| | for 2 years. He believed the man had been involved in a prostitution ring in the |
| | past. He had noticed drug drop-offs since September. He had opened cases with |
| | the police about cars and people. Cllr Bartle asked what the police were doing |
| | about the cases. He replied that they were not doing anything although he had |
| | been visited by a police officer in April. He was concerned about drugs and |
| | worried for his family. |
| | The landlord complained about the smell of urine in the area. |

| | psychotic episode. Witness statements will help to build evidence. | |
| | c) The Parish Council had contacted the Fire & Rescue service because of | |
| | oil spills and reports of fires. They will come and carry out a fire risk | |
| | assessment. | |
| | d) The person is a Shrivenham resident who has fallen on hard times. The | |
| | Council needs to help him move on although he has refused all help so | |
| | far. | |
| | e) The Council had taken legal advice and had been informed that there | |
| | was no point in evicting the person unless we can restrict access to | |
| | prevent his return. | |
| | f) The Council intends to write to the person informing him that we intend to | |
| | take enforcement action. While this could lead to a full possession order | |
| | it will not work unless we can prevent his return. | |
| | g) The car park is an alternative parking place for the High Street and the | |
| | school. Restricting access would have a serious impact on the wider | |
| | community. It would be better to deal with the matter in a holistic way. | |
| | h) The letter will give the person 2 weeks to leave the car park after which | |
| | enforcement action would be taken. | |
| | i) Court action will take a minimum of 8 weeks and then another 5-10 | |
| | weeks if he does not move. | |
| | j) The Council would not be able to fund this action unless it could be sure | |
| | that the person would not return. | |
| | k) He asked the resident for the case numbers of the reports he had filed. | |
| | The landlord complained again about the smell of urine and of a dead bird. | |
| | A resident asked what evidence was required for the Environmental Health team. | |
| | He had tried calling 999 but had been cut off as the matter was not considered | |
| | urgent. | |
| | Cllr Coffey explained that the staff had been clearing up in the area but would | |
| | stop doing so. He also explained that non-urgent matters should be reported on | |
| | 101 but if a psychotic episode was witnessed people should call 999. | |
| | A resident reported that the police had told them not to take photos or videos of | |
| | the man as this was an infringement of his rights. | |
